



## Village of San Leanna DECLARATION OF LOCAL DISASTER

**WHEREAS**, Gregg Abbott, Governor of the State of Texas, certified on the 12<sup>th</sup> day of February 2021 “that severe winter weather poses an imminent threat of widespread and severe property damage, injury and loss of life due to prolonged freezing temperatures, heavy snow, and freezing rain statewide” and declared a state of disaster in all 254 counties based on the existence of such threat; and

**WHEREAS**, the Village of San Leanna on this the 18<sup>th</sup> day of February, 2021 is, and has been since February 14<sup>th</sup> 2021, under imminent threat of widespread or severe damage, injury, or loss of life or property resulting from on-going freezing weather conditions, heavy snow, and freezing rain; and

**WHEREAS**, the Mayor of the Village of San Leanna has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property; and

**WHEREAS**, pursuant to the authority granted to the mayor under the Texas Disaster Act of 1975, Mayor Molly Quirk authorizes the use of all available resources of state government and political subdivisions to assist in the Village’s response to this situation:

**NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF THE VILLAGE OF SAN LEANNA, TEXAS:**

1. That a local state of disaster is hereby declared for the Village of San Leanna pursuant to §418.108 (a) of the Texas Local Government Code.
2. Pursuant to §418.108 (b) of the Government Code the state of disaster shall continue for a period of no more than seven (7) days from the date of this declaration unless continued, or renewed by the Board of Aldermen of the Village of San Leanna.
3. Pursuant to §418.108 (c) of the Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the City Administrator.
4. Pursuant to §418.108 (d) of the Government Code, this declaration of a local state of disaster activates the Village of San Leanna Emergency Management Plan.
5. This Declaration of Mayor Molly Quirk hereby incorporates for all purposes the Declaration of Gregg Abbott, Governor of the State of Texas, wherein he certified that on the 12<sup>th</sup> day of February 2021 “severe winter weather poses an imminent threat of widespread and severe property damage, injury and loss of life due to prolonged freezing temperatures, heavy snow, and freezing rain statewide” and declared a state of disaster in all 254 counties, inclusive of the Village of San Leanna, based on the existence of such threat.
6. That this proclamation shall take effect immediately from and after its issuance.
